# **REMINDERS:**

- <u>Attend</u> your court date on Zoom or in person: Failure to attend court will result in a <u>judgment being entered</u> <u>against you</u>.
- Access Zoom via computer, tablet, smartphone, or phone call: date/time is on your paperwork.
- Log in 10 minutes early in case you are first on the docket.
- Download Zoom app\* days <u>in</u> <u>advance</u> to avoid technical delays. (See page 9.)

# JOIN MEETING: COMPUTER

In your internet browser, type: zoom.us
 In the top right corner, click Join



4. A pop-up window will appear. The site is trying to open Zoom Meetings. The pop-up window will look like one of these:



- 5. You have 2 options:
  - Click Open or Allow in the pop-up window.
  - If nothing happens, Click Launch Meeting

# **MUTE/UNMUTE: COMPUTER**

1. Go to the bottom right corner of your zoom screen, click on the mic.



2. When there is a red slash on the mic, you're muted.



# **ADDITIONAL TIPS**

• After joining a meeting, a pop-up window will appear. Click **Join**

• To turn the camera on or off, click the camera icon at the bottom left corner of your screen.



 You do not need to have a webcam to use Zoom; you can use only audio if needed.

- To reduce echo, mute your mic when not speaking.
- Do not log into Zoom with 2 devices at once: it will cause audio issues.

# **TECH ISSUES?**

- If the host hasn't started the meeting or if the host hasn't let you in yet, please wait until you are let into the call.
- If you are waiting more than 5 minutes to be let into the call, leave the meeting and rejoin to reset.
- If this process takes more than 5 minutes, please call the assistance number at the end of this guide.

# **MUTE/UNMUTE: PHONE**

- 1. Press \*6 (star; then 6) to mute yourself when you enter the call
- 2. Press \*6 (star; then 6) to unmute yourself when your case gets called
